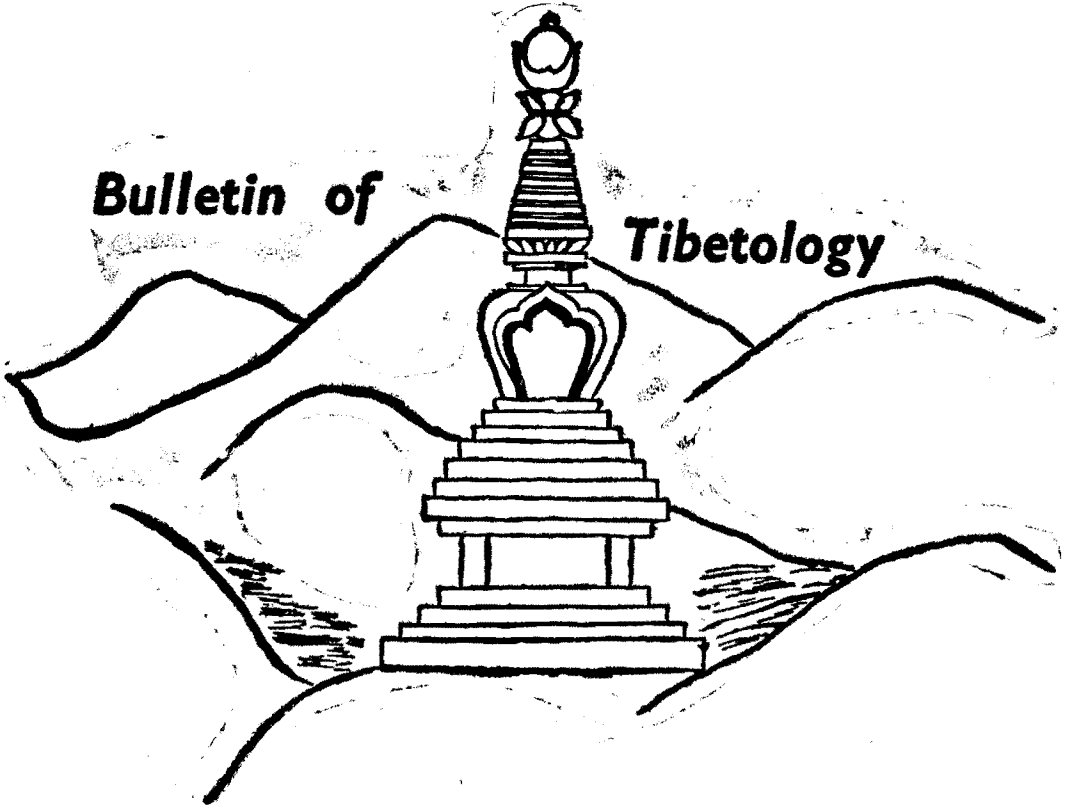

RECHUNG RIMPOCHE: Research Officer in three Institute of Tibetology. He began his scholastic studies in the Dephung Monastery near Lhasa. KUNGA YONTEN HOCHOTSANG Follower of Sakya Order from Derge (Kham); resident in Sikkim since 1959 and attached to the Namgyal Institute of Tibetology, first as a student of Sanskrit and English, later English Language Teacher Nyingma Sheda and Tibetan Teacher, Tashi Namgyal Academy and presently Research Assistant at the Namgyal Institute of Tibetology.
