## **Replicates**

Number of biological (n) and technical replicates in each experiment are clearly described in the methods and in the individual figure legends. Data is provided as individual results in the figure panels and/or available as supplementary material and/or deposited in a public repository.

The handling of outliers and the criteria for data exclusion are clearly stated in the raw data processing description and in the statistical analysis sub-section of the methods. Samples failing the quality control tests and therefore deemed as outliers in the lipidomics analysis are highlighted in the supplemental tables.

# **Statistical reporting**
